We believe the extent of the growth in long-term earnings power for Montaka's portfolio businesses is currently being underestimated by their current respective stock prices.

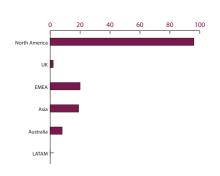


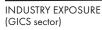

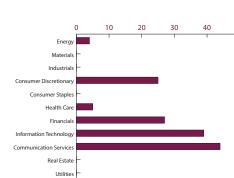

LONG PORTFOLIO* (as at 30 June 2021)

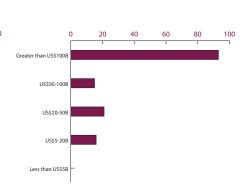
GEOGRAPHIC EXPOSURE (Country of domicile)





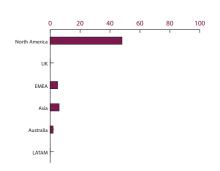


MARKET CAP EXPOSURE

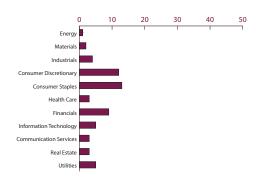


SHORT PORTFOLIO* (as at 30 June 2021)

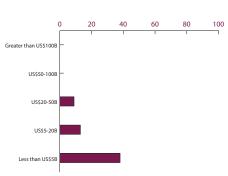
GEOGRAPHIC EXPOSURE (Country of domicile)
