FUND COMMENTARY

In November, the Montaka Global Access Fund delivered a return of 1.95 per cent, net of fees. Over the same period, the MSCI World Total Return Index in Australian dollars (the Global Market) returned 3.19 per cent. Since inception, the Fund has returned 11.39 per cent, net of fees, with an average net market exposure of 47 per cent. Over the same period, the Global Market returned 19.28 per cent, but with 100 per cent net market exposure.

Recent weeks have been characterised by a number of globally-significant political events that are worth monitoring into 2018. In China, President Xi has now established himself as the most powerful domestic leader since Mao. In Saudi Arabia, Crown Prince MBS effected the surprise arrest of a large number of royal, political and business figures for "corruption". The US Senate has now passed the largest set of changes to the US tax code in more than three decades. While on the same day, President Trump's former National Security Advisor, Michael Flynn, pleaded guilty to lying to the FBI. Finally, North Korea launched a missile that demonstrates a new capability to reach the east coast of the US.

We are very excited by the businesses we own and believe they remain materially undervalued. That said, the world remains an unpredictable place. As such, we continue to operate with a healthy dose of conservatism reflected in the Fund's net market exposure of 41.6 per cent at month end. We are particularly excited by the opportunities we have identified in the Fund's short portfolio and believe many of these will become a great source of value in 2018.
