FUND COMMENTARY

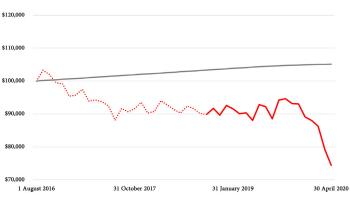
Further to our recent communications in relation to the wind up of the Montgomery Alpha Plus Fund, the Fund's portfolio positions were progressively exited during the latter part of April. While this process has now been substantially concluded, the adverse market conditions that have recently impacted the Fund – along with other quantitative equity funds – persisted into April, contributing to a 6.14 per cent decline in fund net assets for the month.

With the liquidation of Fund positions now substantially complete, we anticipate that more than 95 per cent of Fund capital will be returned

to investors within the next week. Some remaining exposures will require additional time to close, for example where dividends are yet to be received or corporate actions yet to conclude, and we anticipate a second smaller return of capital will follow as these positions are resolved. We expect to provide further detail on this shortly.

While losses are sometimes part and parcel of investing in equity markets, this has clearly been a disappointing voyage for you and for us. We hope that you may enjoy better fortune in your future investment journeys.

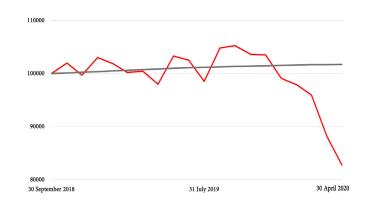
PERFORMANCE GRAPH SINCE INCEPTION
