We continue to maintain a relatively defensive posture overall, despite possessing a rich opportunity set. Broader equity markets have been extremely strong, rising circa 10% in November alone. Despite the strong backdrop prima facie, we are expecting an uptick in volatility in the coming months. Equity markets are simmering within an environment of accommodative monetary policy which we discussed briefly last month. We are living through unprecedented times and accordingly we are treading cautiously whilst still maintaining a reasonable level of market exposure.
