April

During April, the Fund increased 2.7% net of all fees. The Benchmark increased 2.8% over the same period. We ended the month with 18 individual positions in total and with a net cash position of 40%. Our table with monthly historical returns from prior months is at the bottom of this update.

What's next?

We are travelling to Omaha Nebraska this week to attend the legendary investor Warren Buffett's annual meeting. We look forward to learning from Buffett himself as well as swapping notes with a wide range of global fund managers and investors.
