During December, the Fund rose 2.8% net of all fees while our Benchmark rose 7.2% over the same period. We ended the month with 20 individual positions in total and with a net cash position of 16%.

What's next?

We are actively deploying cash and in some new positions we have been the biggest buyers in the market. We look forward to discussing these new positions once we have built a full position.
