## July

During July, the Fund increased 3.6% net of all fees. The Benchmark increased 3.5% over the same period. We ended the month with 19 individual positions in total and with a net cash position of 30%.

## What's next?

We have just gone through and revalued every one of our positions ahead of the full\_year earnings results.
