June

During June, the Fund increased 0.6% net of all fees. The Benchmark was flat at 0% return over the same period. We ended the month with 19 individual positions in total and with a net cash position of 33%.

For the 2023 financial year, the fund will pay a distribution of 6.18 cents. Our table with monthly historical returns from prior months is at the bottom of this update (note that the unit price, portfolio value, and cash weighting are reported on a pre-distribution basis).

What's next?

We are heading into reporting system and are gearing up for a hectic couple of months ahead – we look forward to share more on how our favourite companies are performing.
