March

During March, the Fund declined 0.5% net of all fees. The Benchmark declined 0.7% over the same period. We ended the month with 19 individual positions in total and with a net cash position of 42%. Our table with monthly historical returns from prior months is at the bottom of this update.

We initiated some exciting new positions this month which we look forward to discussing in a future update as we build out full positions.
