October

During October, the Fund declined -2.9% net of all fees while our Benchmark declined -5.5% over the same period. We ended the month with 17 individual positions in total and with a net cash position of 30%.

What's next?

We're in the final stages of due diligence on a new position and look forward to sharing more in the months ahead.
