Fund Commentary

Global equities closed the month lower as concerns over the Ukraine-Russia war, persistent inflation and higher interest rates seemingly dampened risk appetite. Additionally, slowdown fears in some of the world's largest economies also sparked bouts of volatility. For June 2022, the Polen Capital Global Growth Fund (the Fund) declined by 4.44 per cent, while the MSCI ACWI (the Benchmark), declined by 4.47 per cent.

Stock selection within the health care sector, specifically German medical device business Siemens Healthineers, detracted from relative returns, with the bottom three relative detractors from performance being Adobe Inc, Autodesk Inc, and Siemens Healthineers. Conversely, stock selection within the financials sector contributed positively to relative returns, led by AON PLC.

Polen Capital continue to believe that the Fund is well-positioned for long-term growth. Despite the different styles that will inevitably drift in and out of favor, Polen Capital feel confident that their disciplined and consistent investment approach will stand up well as they believe that the underlying earnings growth of the Portfolio will drive the long-term investment outcome. Polen Capital also believe the secular tailwinds that many of the Fund's businesses are benefitting from will persist for years to come, potentially serving as engines to bolster growth.

The Polen Capital Global Growth Fund will not be paying a distribution for the year to 30 June 2022.




